- By participating entrant agrees to abide by these Official Rules and the decisions of The Huntsville Madison County Builders Association, Inc. herein referred to as HMCBA.
- The Entry Period begins at noon, Friday, March 1, 2024 and ends at 5:00 pm, Sunday, March 3 at the Spring Home + Garden Showsm herein referred to as the Show.
- Prize drawings are open only to participants who are legal residents of the United States of America, and who are 18 years of age or older as of January 1, 2024.
- The Entry Registration form must be filled out completely to be eligible for the drawing.
- Only one registration form per person. Multiple registration forms received from the same person will disqualify you from the prize. All entries become the property of HMCBA. Unless you mark otherwise on the Registration form, your name and address may be shared with participating companies.
- The Prize Winner will be selected by the HMCBA after close of The Show, Monday, March 4th, at random from all eligible entries received during the Entry Period. The winner will be contacted no later than Monday, March 18, 2024. The winner will be contacted via email. The winner has five (5) days to respond back to the prize notification email.
- If the prize notification email is unanswered or not returned within the allotted time, (5 days) or if the winner declines the prize or are ineligible, an alternate winner will be selected.

- The Winner is responsible for all shipping, taxes, and any other expenses related to the acceptance and use of prize. The Winner is responsible for picking up the prize at the exhibiting company's store within the time frame designated by the exhibiting company. Reflections Home Furnishings has given the Winner until December 31, 2024 to utilize the prize.
